Democracy, Management, and Digital Participation

CONTEXT

Democracy can no longer be conceived separately from the changes transforming our societies: from growing inequalities to the digital revolution. These phenomena not only challenge the responsiveness of institutions, but also profoundly reshape the relationships between governments and citizens. Cities, due to their closeness to everyday life, become privileged spaces to experiment with new forms of public management. In this sense, digital tools can open the door to more open, collaborative, and transparent practices, but they can also deepen inequalities if not accompanied by policies of inclusion and regulation. The question is no longer whether we should "digitalize" government, but how to do so in a way that enhances democracy instead of fragmenting it.











The incorporation of digital tools in public management should not be understood merely as technical modernization, but as a rethinking of how public decisions are made and who participates in them. Initiatives such as digital participatory budgets, citizen consultation platforms, or the use of artificial intelligence in social policies demonstrate the transformative potential of digital technology. However, tensions also emerge: automated decisions without human oversight, algorithmic biases, or the risk of mass surveillance.

This session proposes to reflect on the **role of technology in transforming local public management and strengthening democratic practices**. It aims to go beyond technological enthusiasm and ask what **kind of democracy we want to build in the digital era**. Only an **integrated vision** — one that links technology, rights, and community — will allow us to harness the digital to create fairer, more transparent, and livable cities for all.

OBJECTIVES

- Reflect on the impact of digital transformation on the relationships between governments and citizens, and how it reshapes governance in urban contexts.
- Debate how to incorporate technology into public management not merely as a technical improvement, but as an opportunity to strengthen democracy, inclusion, and citizen participation.
- Analyze concrete experiences of democratic digitalization such as digital
 participatory budgets, consultation platforms, or artificial intelligence applied to
 public policy as well as the risks associated with automation, algorithmic
 bias, and surveillance.
- Explore the elements necessary for a digital transformation with an integrated approach, linking technology, accountability mechanisms, digital literacy, and rights.

METHODOLOGY

This **90-minute panel** will begin with an introduction to establish the foundations of the relationship between governance and technology. Then, **a panel of representatives** from local governments will share their experiences and models of digitalization and use of technology in public management, addressing issues of democratic digitalization, transparency, and digital risks. The speakers will have the opportunity to comment on their experiences, discuss practices, and explore solutions to move towards more accessible and equitable urban governance. An interactive question-and-answer session will follow, encouraging audience participation.











GUIDING QUESTIONS

- How can digital transformation strengthen or weaken democracy at the local level and bring the state closer to citizens?
- What ethical, legal, institutional, and technological conditions are necessary for the incorporation of technology in public management to promote real and effective citizen participation?
- What ethical and political tensions arise from the use of digital tools in public decision-making?
- What kind of governance do we want to build in the digital age, and how does it align with the principles of inclusion, social justice, and citizens' rights?
